- 1) Registration, Participants must first register for the event.
- 2) Two Types of Participants:

Paper Presenter: Those who intend to submit and present a research paper.

Participant (non-presenter): Those who attend without submitting a paper.

Abstract Submission (for Paper Presenters only)

Authors submit an abstract of their research.

4) Review Process

The abstract undergoes a review process. If rejected, authors were given the opportunity to revise and resubmit after addressing the reviewers' comments.

The acceptance or rejection of a revised manuscript was final. If accepted, the author is invited to submit a full paper.

5) Full Paper Submission

The accepted abstract leads to a full research paper submission.

6) Oral Presentation

Authors must present their paper at the conference.

Review & Revision

After the presentation, further review and revisions may be required.

- Publication, Once the paper is reviewed and revised, it is published.
- 9) Final Publication

2. QUALITY CRITERIA

Reviewers were assigned with consideration of having experience as reviewers in several academic journals and in accordance with the scientific field of the article being reviewed. Reviewers are instructed to assess the quality of the article based on conformity with the conference theme, article template as well as the academic feasibility and substance of the article.

In addition, all articles reviewed were checked for similarity using a plagiarism checker. Decided reasonableness limit < 25%.
